Health and Safety software is a centralized, cloud-based system that enables the management and the sharing of compliance data, tasks and actions across an entire company.


Our cloud-based software means that you have all your Health and Safety documentation available at your fingertips.



Under the COSHH Regulations 2002 is it a legal requirement that any wearer of tight or close fitting RPE, including, disposable half mask, re-usable filter or cartridge half masks, powered respirators, full face filter or cartridge masks undertakes FFT to ensure a correctly fitting device.



#### Fire Risk Assessments

The fire risk assessment is a five step process that should:

- 1) Identify the hazard
- 2) Consider who may be at risk
- 3) Evaluate the risk, eliminate or reduce the risk from fire as far as is reasonably possible and provide general fire precautions to deal with any possible risk
- **4)** Create a plan to deal with any emergency, keep a record of your findings and train staff what to do in the event of an emergency
- **5)** Review your findings when necessary

Risk Assessments, Method Statements (RAMS) play a vital role in any industry today.

More and more cases of individuals being prosecuted due lack of documentation are coming to light in recet years. MNA can formulate suites of documentation that comply with current regulations to ensure your workforce and busniess compliant.



RAMS are a combined document made up of a Risk Assessment (RA) and Method Statement (MS) that details how the job in question will be carried out. It outlines what potential injuries could be sustained from this job and what is done to reduce the risk of injury to all personnel involved. It should not be a form filling exercise but a fundamental part of any job.
